

SUMMARY ANNUAL REPORT

For Pearson Education, Inc. Welfare Benefit Plan

This is a summary of the annual report of the Pearson Education, Inc. Welfare Benefit Plan, EIN 22-1603684, Plan No. 510, for period 01/01/2024 through 12/31/2024. The annual report has been filed with the Employee Benefits Security Administration, U.S. Department of Labor, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

Pearson Education, Inc. has committed itself to pay certain self-insured Medical, Prescription Drug, Dental, and Short-term Disability claims incurred under the terms of the plan.

Insurance Information

The plan has contracts with Kaiser Foundation Health Plan, Inc., Vision Service Plan, Cigna Health and Life Insurance Company and Affiliates, Hawaii Medical Service Association, Lincoln National Life Insurance Company, Triple S Salud, Inc., MetLife Legal Plans, and Lincoln Life & Annuity Company of New York to pay Medical, Prescription Drug, Dental, Vision, Life Insurance, Long-term Disability, Accidental Death and Dismemberment, and Legal claims incurred under the terms of the plan. The total premiums paid for the plan year ending 12/31/2024 were \$7,382,468.

Because they are so called "experience-rated" contracts, the premium costs are affected by, among other things, the number and size of claims. Of the total insurance premiums paid for the plan year ending 12/31/2024, the premiums paid under such "experience-rated" contracts were \$150,128 and the total of all benefit claims paid under these contracts during the plan year was \$157,928.
